HIV/AIDS	 Infectious Difficult to cure over long-term High treatment cost 	 Accepted to register as a student if the HIV status is stable and asymptomatic and fulfils the following criteria: CD4>350mm³/L Liver function test-normal Hb >10gm % No evidence of opportunistic infection. The student is willing to the bear his/her own cost (outside the scheme) for the relevant treatment. Does not take a course where there is a possibility of infection through blood (blood-borne infection). 	 Allowed to continue the studies with the following conditions: The student is willing to the bear his/her own cost (outside the scheme) for the relevant treatment. Approval is for the continuation of the current course ONLY, with the condition that the student does not take a course where there is a possibility of infection through blood (bloodborne infection). KPM needs to provide HIV counseling sessions for this student. KPM needs to have a mechanism to monitor the health status of student to ensure that the student is in a healthy condition.

Hepatitis B	 Infectious Difficult to cure over long-term High treatment cost 	 Can be accepted to register as a student if the Hepatitis B status is non-infectious i.e after carrying out a subsequent confirmatory test (Hepatitis Be antigen and Hepatitis Be antibodies). The student is willing to the bear his/her own cost (outside the scheme) for the relevant treatment. Approval is for the current course ONLY, with the condition that the student does not take a course where there is a possibility of infection through blood (blood-borne infection). 	 Allowed to continue the studies with the following conditions: The student is willing to the bear his/her own cost (outside the scheme) for the relevant treatment. Approval is for the continuation of the current course ONLY, with the condition that the student does not take a course where there is a possibility of infection through blood (bloodborne infection).

Tuberculosis	Infectious Expected to be cured with treatment for a specified period	 Defer registration until the TB treatment is completed and status is inactive TB in the home country (≤2 semesters). Need confirmation from the treating Physician that the status is inactive TB before being allowed to register for studies in Malaysia. 	 Defer studies immediately and to be given initial treatment in Malaysia until the sputum is negative. Subsequently the student is to return home to complete the TB treatment in his home country. Allowed to continue the studies after completion of the treatment in the home country and the status is confirmed as inactive TB by a Physician. Allowed to defer registration for ≤2 semesters ONLY. KPM needs to have a mechanism to monitor the health status of the student to ensure that the TB is not spread to other students and the community.
4.	Malaria	 Infectious Expected to be recover with short- term treatment 	 Allowed to register. Allowed to start studies after receiving treatment and certified as negative for Malaria by a doctor. The student is willing to the bear his/her own cost (outside the scheme) for the relevant treatment. 	 Allowed to continue the studies after receiving treatment and confirmed to be negative for Malaria. Undergo the treatment provided the student is willing to bear his/her own cost (outside the scheme) for the relevant treatment.
5.	Typhoid	 Infectious Expected to be recover with short- term treatment 	 Allowed to register. Allowed to start the studies after completing treatment and certified as having recovered by a doctor. Undergo the treatment provided the student is willing to bear his/her own cost (outside the scheme) for the relevant treatment. 	 Allowed to continue the studies after completing treatment. Undergo treatment provided the student is willing to bear his/her own cost (outside the scheme) for the relevant treatment.
6.	Syphilis	 Infectious Expected to be recover with short-term treatment 	 Allowed to register. Allowed to start the studies after completing treatment. Need to provide a letter of completion of treatment from the treating doctor. Undergo treatment provided the student is willing to bear his/her own cost (outside the scheme) for the relevant treatment. 	 Allowed to continue the studies after completing treatment from the treating doctor (Monitoring is needed for follow-up treatment to ensure the period of treatment and VDRL status. Undergo treatment provided the student is willing to bear his/her own cost (outside the scheme) for the relevant treatment.

Allowed to register, subject to confirmation from the treating Physician that the epileptic status is stable with treatment. Not suitable for certain courses that involve the handling of machinery. 	 Allowed to continue the studies, subject to receiving confirmation from a Specialist that the epileptic status is stable with treatment. Undergo treatment provided the student is willing to bear his/her own cost (outside the scheme) for the relevant treatment. Not suitable for certain courses that involve the handling of machinery.
3.	Dialysis	 Expected to continue for long-term. Obvious and serious symptoms Long-term treatment 	 Not accepted for registration as a student. 	 Continue with the studies provided: The symptoms do not affect the studies The student is willing to bear his/her own treatment cost (outside the scheme).
